LICENSEE and the DIVISION OF OCCUPATIONAL AND PROFESSIONAL LICENSING (“Division”) of the Utah Department of Commerce, upon acceptance by the Division, agree as follows:

1. Licensee hereby tenders their license as a Hearing Instrument Specialist or Hearing Instrument Specialist Intern to the Division, informing the Division that they wish to surrender their license to the Division.
2. Licensee acknowledges that the Division is not required to accept this agreement but upon signature on this document by the Licensee, the Division will evaluate this request. If the agreement is not approved by the Division, this agreement is null and void and without any force or effect whatsoever.
3. Licensee admits the jurisdiction of the Division over them and over the subject matter of this request.
4. Licensee affirms that they are offering to surrender their license voluntarily of their own free will and choice without any undue inducement, coercion, or threat from any source, and that the only promises or understandings they have obtained from the Division regarding the surrender of their license are those contained in this Agreement.
5. Licensee acknowledges that they have been informed of their right to be represented by counsel, and that they have chosen not to be so represented.
6. Licensee understands that if this request is granted they will forfeit all right to practice as a Hearing Instrument Specialist in Utah unless and until they apply for reinstatement of licensure and their application is approved by the Division.

7. Licensee understands that if they apply for reinstatement of licensure, they must meet all the requirements for a new license unless those requirements are waived by the Division, in whole or in part, upon a review of the application.

8. Request for inactive status. Check whether inactive status desired. YES NO

If yes, you must submit a \$50.00 fee. If fee is not submitted with this document, even if yes is selected above, the subject license will not be placed on inactive status.

If the above is checked yes and the \$50.00 fee is paid, upon verification that the license is in good standing the license may be placed on inactive status. Renewal fees must be timely paid to the Division for each renewal date to continue inactive status.

9. Licensee understands that they will not receive any refund of license or renewal fees previously paid to the Division.

10. Licensee acknowledges that no representations regarding a future waiver of licensure requirements have been extended to them except as stated herein.

11. This agreement is not a finding of unprofessional or unlawful conduct nor is it disciplinary action against the Licensee. The Division retains any jurisdiction to subsequently initiate disciplinary proceedings for any conduct the licensee may have engaged in prior to the date of this agreement or may engage in subsequent to the date of this agreement.

12. Licensee acknowledges that they were informed that their request may be withdrawn at any time prior to this agreement being entered into herein by the Director or his designee.

13. Licensee acknowledges that if this request is accepted by the Division, it will be classified as a public document and may be released to the public upon request. In addition, the Division is authorized to inform other state and federal agencies of the action taken herein and of the content of this Stipulation and Order.

14. This document constitutes the entire agreement between the parties and supersedes and cancels any and all prior negotiations, representations, understandings, or agreements between the parties. There are no verbal agreements which modify, interpret, construe, or affect this Agreement. The person signing this agreement hereby certifies that he has authority on behalf of the licensee to sign this document.
